# ARTICLES OF INCORPORATION

MAOWING The undersigned, a resident of the State of Wyong EDRETARY OF STATE 1 age, acting as incorporator of a non-profit corporation under W.R.S. Section 17-6-101, adopts the following Articles of Incorporation for such corporation.

#### ARTICLE I

The Name of this Corporation is "Sprucewood Condominium Association" (the "Association").

#### ARTICLE II -

The term of existence of this Corporation is perpetual.

#### ARTICLE 111

The address of the Corporation's initial registered office shall be 265 Aspen Drive (P.O. Box 250, Moran, Wyoming 83013) The Corporation's initial registered agent at said address shall be Christopher P. Kirk

#### ARTICLE IV

# Purposes and Owners of the Association

This Association is organized as a non-profit corporation and does not comtemplate or permit pecuniary gain or profit to the members, officers or directors, thereof, either directly or indirectly, and the specific purposes for which it is formed are to provide maintenance, preservation, operation and governing of a certain condominium project, referred to as Sprucewood Condominium Association (hereinafter referred to as the "Project"), which is located upon the following described real property in the County of Teton, State of Wyoming:

> Lots 5 & 6, Block 2 of the Aspen Hill Addition to the town of Jackson

and to promote the health, safety and welfare of the owners and residents of units within the above-described project. The Association shall have and exercise each and all of the following powers and privileges in carrying out the foregoing purposes:


- (a) The owner to exercise all of the powers and privileges and to perform all of the duties and obligations of the Association as set forth in that certain Declaration of Covenants, Conditions and Restrictions for the Project, hereinafter called the "Declaration", applicable to the property and recorded, or to be recorded, in the office of the Teton County Clerk, and as the same may be amended from time to time as therein provided; said Declaration being incorporated herein as if set forth at length;
- (b) The power to fix, levy, collect and enforce payment by all lawful means, of all charges or assessments of fines pursuant to the terms of the Declaration; to pay all expenses in connection therewith and all office and other expenses incident to the conduct of the business of the Associaton;
- (c) The power to acquire, own, hold, improve, build upon, operate; maintain, lease, mortgage, sell, transfer, dedicate for public use or otherwise dispose of real or personal property in connection with the affairs of the Association: and.

(d) To have and to exercise any and all powers, rights and privileges which a corporation organized under the Non-Profit Corporation Law of the State of Wyoming may, by law, now or hereafter have or exercise. This statement of corporate powers and purposes shall be broadly construed to effectuate the corporate purposes.

ARTICLE V

# Membership

The members of the Association shall be all record owners of the AliG 5 Condominiums within the Project as such owners are shown on the records of Secretarine County Clerk of Teton County, State of Wyoming. The term record owner of State shall not include any mortgage, trustee, or beneficiary under any mortgage, Wyoming trust deed, or other security instrument by which a Condominium or any part



#### ARTICLE VI

## Voting Rights

Voting rights in the Association shall be exercised by the members on the basis on one vot per condominium, on the terms provided in the Declaration.

## ARTICLE VIJ

## Board of Directors

The affairs of this Association shall be managed by a board of not less than three (3) Directors, who need not be members of the Association. The number of Directors may be changed by amendment of the By-laws of the Association. The names and addresses of the persons who are to act in the capacity of Directors, until the first annual meeting of the Board of Directors and until their successors are elected and shall qualify are:

The Board of Directors may by written contract, delegate to a professional management organization or individual such of its managerial duties, responsibilities, functions and powers as are permitted to be delegated under and by virtue of the Declaration and By-laws of the Association.

## ARTICLE VITI

## By-laws

Provisions for the regulation of the internal affairs of the Association shall be set forth in the By-laws shall not be in consistent with the privisions of these Articles of Incorporation or the Declaration. The By-laws of the Association shall be adopted by the Board of Directors.

#### ARTICLE IX

#### Dissolution

The Association may be dissolved by a resolution adopted by the affirmative vote of two-thirds (2/3) of the members at any general or special meeting called in accordance with the By-laws. In the event of the dissolution, the assets of the Association shall be liquidated into an unincorporated association of the members or other similar entity, or as a court may direct.

#### ARTICLE X

#### Incorporator
